

A baby dies

Training focus

This 2-day course focuses on caring for families experiencing perinatal loss (e.g., miscarriage, stillbirth, prenatal life-limiting diagnoses, newborn death).

- describe the importance of follow-up support as a component of a bereavement standard of care
- list three self-care strategies for caregivers
- describe person-centered care through a diversity, equity, inclusion, and anti-racism lens
- define "perinatal palliative care"

When RTS was founded in 1981 as a perinatal bereavement program, it identified a critical element of bereavement care: relationship between a care provider and the bereaved family. An interprofessional team came together to form the planning committee and helped develop the first training. All were committed to establishing perinatal bereavement processes that were centered on the patient's and family's experience and supported by a standard of care.

Today, RTS offers bereavement education in perinatal, neonatal, pediatric, and adult death as well as Coordinator Training to allow RTS professionals to train their own staff. RTS is a national and international leader in bereavement education and research.
